Application Process

This is the process by which bookable access facilities can be requested:

- Purchase a ticket through <u>DICE</u> or <u>our instalment</u> <u>plans</u>
- Attach a screenshot of your ticket or complete the form below with the email you purchased the tickets with
- Complete the Access requirement form below and any supporting evidence
- We will then issue you a P.A ticket to present upon arrival at the 'Guest list' queue at the Wristband Exchange (main entrance tent), in order to receive your wristband(s).
